



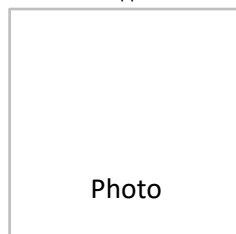

Notes for Applicants applying for Membership

Thank you for applying for membership of the Hebe Haven Yacht Club (HHYC). We would like to share with you the membership application process and provide some guidance that will help you to share your experience and motivation to join the Club with the Membership panel.

Understanding the Club culture and suitable applicants

The Club is a reflection of its members who shape the culture and service that the Club provides, so it is our duty to safeguard that culture for all members to enjoy.

We are also bound by the requirements of our government lease as to what activities we can promote and engage in. There is a priority for us to drive and support competitive and recreational sailing as part of our remit to retain the lease.

Our main funding and much of the practical support comes from members along with the sponsorship of sailing activities from individuals and businesses. Active participation in the Club is therefore essential to its long-term wellbeing.

The Club is directed by member sub committees. It is vital that members are prepared to invest in their Club through participation in these committees where they have expertise.

The Club is governed by the Articles of Association and the Byelaws. If successful, you will be required to sign a confirmation that you agree to abide by all.

Our food and beverage (F&B) facilities are for members and guests use only and are provided as a support service to the key activities of the Club (as detailed below), F&B services should not be the sole driver for an application.

With these key activities in mind, we consider our core membership to be:

- Those who sail or have sailing experience at whatever level and are keen to use the Club for this purpose.
- Those who are keen to learn to sail through our training programmes and participation in social and competitive sailing events.
- Those who use powerboats and personal watercraft (jet skis) for recreational purposes.
- Those who are personally willing to support the activities of the Club in areas such as race management, instructing and, or providing input into the Club's sub committees (You will be expected to participate in some of these activities starting in your first year, should your application be successful).

Priority will, therefore, be given to applicants who best reflect one, or preferably, more of the above-mentioned criteria.

Please also note:-

- Our allocation of marine berths, swing moorings, hardstand and racking is currently full and with a considerable waiting list in all categories.
- We do not entertain any application where there is any commercial element in the member's application (e.g. running a business using the Club premises and/or facilities).
- Applicants should note that, as with all clubs in Hong Kong operating under a Private Recreational Lease (PRL) administered by the Culture, Sports and Tourism Bureau (CSTB) the PRL of the Hebe Haven Yacht Club is subject to periodic renewal, the next renewal being due in 2027. While the Club constantly endeavours to meet (and indeed exceed) the requirements of CSTB and is already diligently preparing for the next renewal of its PRL, such renewal cannot be guaranteed. Applicants should be aware that in the unlikely event that the Club's PRL is not renewed in 2027, the Club would have no option but to wind up its operations, in which case there will be no refund of any entrance fees paid.

The Club may hold your information for up to 12 months if there is reason to do so as part of the process, after which, if you have not become a member, the application will be destroyed. On becoming a member, the information provided by you may be transferred to the Club database.
