Annex to Notice of Annual General Meeting 2025 Notes on Voting by Proxy

- 1) Members are entitled to appoint their spouse or another person who is a member to exercise all or any of their rights to attend, speak and vote at the AGM.
- 2) A proxy may only be appointed by a notice in writing ("Proxy Notice") in the form provided by the Club ("Proxy Form") which will be available from 7:30pm on Thursday, 6 November 2025 (two weeks before the AGM) and which can be obtained either:
 - (i) by collection in person from the Club's Membership Office; or
 - (ii) upon request by email to proxyvote2025@hhyc.org.hk, a dedicated email account set up expressly for the purpose of administering the Proxy Notices and which will only be accessible by authorised Club staff and the AGM auditor.
- Members <u>must</u> use their email address as registered with the Club for requesting proxy forms by email and <u>must</u> clearly state their full name and membership number in the requesting email. Requests using email accounts not registered by the member with the Club will <u>not</u> be entertained.
